

NOTICE OF AVAILABILITY OF STATE-OWNED AREAS FOR REQUESTING A MARITIME PUBLIC CONCESSION for the Construction of Solar Energy Production Plants – pursuant to Italian Legislative Decree No. 387/2003 and subsequent amendments and additions



2. GENERAL INFORMATION

- 2.1 The Port Network Authority of the Ionian Sea hereby announces the availability of maritime state-owned areas intended for the construction of solar energy production plants, both onshore and offshore. Therefore, interested parties must submit a request to MASE (Ministero dell'Ambiente e della Sicurezza Energetica Ministry of Environment and Energy Security) to obtain authorisation for the renewable energy production plants as provided by Article 12 of Italian Legislative Decree No. 387/2003 and subsequent amendments and additions; as part of this procedure, the opinion of the competent AdSP (Autorità di Sistema Portuale Port Network Authority) will be obtained.
- 2.2 The Port Network Authority has the following state-owned areas, falling within its jurisdiction, on which the mentioned plant can be constructed. These are, in detail, the areas identified as follows:
 - ✓ State-owned area of approximately 23 hectares, registered in the land registry under sheet number 193. vr. Parcels: 253, 136, 217, 222, 11, 126, 123, 124, 9.
 - ✓ Water surface area of approximately 70 hectares, perimeter of 3,358 meters.

The request may concern either the entire available area or a portion of it, depending on the solution identified by the applicant, which must still meet the specific needs of the Port Network Authority of the Ionian Sea and take into account the cold ironing plants being constructed in public areas and the requirements of the port companies.

4. ELEMENTS OF INTEREST TO THE ADMINISTRATION FOR THE PURSUIT OF PUBLIC INTEREST

To ensure equality and transparency, the Port Network Authority of the Ionian Sea has identified the following evaluation elements, in light of which it will express its opinion within the procedure pursuant to Article 12 of Italian Legislative Decree No. 387/2003 and subsequent amendments and additions:

- > Innovativeness of the proposed technological solutions, also to ensure the minimal environmental impact of the works;
- Energy tariff for: 1) Port Network Authority of the Ionian Sea; 2) Supply of cold ironing plants on public areas (San Cataldo Pier); 3) Companies in the Port of Taranto;
- Methods of using any additional energy produced for uses not provided for in the previous points;
- Construction and commissioning time of the plant.

The economic operators interested in the aforementioned maritime public domain area for the purposes in question must submit an application to the Ministry of Environment and Energy Security and follow the authorisation procedure for renewable energy production plants provided by Article 12 of Italian Legislative Decree No. 387/2003 and subsequent amendments and additions, as well as obtaining all opinions/authorisations/concessions and/or permits necessary for the construction, management, and maintenance of the aforementioned plants.
